2017/45. Minutes

The minutes from the 21st September were taken and read. Signed by Mike Baddeley. Proposed by Mike Farrell Seconded by Pat Fallance. Vote and all in favour.

2017/47. Finance

Account balances

- Current account £2005.79 (£1270.00 is for defibrillator)
- II. Deposit account £12722.25
- III. Two thousand to be moved from deposit to current account in next month. Vote and all in favour to move the money.

2. Defibrillator Grant

We have been successful in getting the grant money, there is a 16-bullet point document that needs to be signed by the chair of the council to accept the quote. £1000 has been granted and we already have £1270 in the bank for the fund raising, so we have £2270 to spend on the defibrillator.

We have 4 quotes for the product and the box, two low spec kits and two higher spec kits. As this has been a fund-raising event and we have the money from that to spend on the kit it has been decided to go for the higher spec and better lasting cabinets. We will choose heartstart as the training and support is better. We would need to budget £50 per year for maintaining the equipment such as pads if needed. Estimated £20 per year for electric. The pub has offered to put it on their wall and fund the electric. This will need to be agreed with the brewery. We need to ask for volunteers for training.

Vic proposes we accept the grant and the Heartstart quote for £2266. All in favour.

3. Clerks wages and pension

Vic Freir is still looking into this and will update at next meeting. Vic Freir and Mike Baddeley will have an appraisal with Gemma before next meeting.

4. CIL Money

We had some issues with the CIL returns report to TDBC, this is now resolved and we have done the report that has been accepted by TDBC.

We are looking to regain ownership of the verge by the woods so we can get gates put up as there is a lot of fly tipping going on.
